

## Vendor Application Windy Acres Farm Winter Craft Fair 2022

Winter Craft Market at Windy Acres Farm in Geneva, IL. Space for approximately 30 vendors or more. Promote your business locally to families of the Fox Valley. Santa Claus/Grinch will be in attendance as well as shopping at the farm and greenhouses open with holiday decor. An adult beverage bar will be open as well as children's workshops, and other family activities.

Vendor Booth space is ~10'x10'. Vendor fee is \$75 a day for one booth space per day. Vendors can rent multiple spaces.

This event will take place in the greenhouse on the farm property. The greenhouse is not heated. Vendors must provide their own display equipment including tables, chairs, extension cords, and be able to set up/break down their displays without assistance. There are no volunteers on site. Electricity is available for an additional purchase of \$15 per day.

All fees are non-refundable once a vendor has been accepted into this event. Any vendor not accepted will not be charged a deposit fee and the transaction will not be processed.

Must remove all valuables from your booth overnight and reset for next day's show. Windy Acres Farm is not responsible for any belongings. Vendors are responsible for any damage caused by their booth or product sales. Windy Acres has the right to make any vendor booth adjustments as needed and will notify vendors accordingly. Outdoor restrooms available.

Please email a few photos of your items for sale along with a snippet of information describing your business. This is a juried market. We are looking for high quality, unique items. All applicants will be notified whether or not they have been accepted to the show. Vendor submittal deadline is Monday November 21st.

Windy Acres Farm will be promoting this event locally and throughout the Chicagoland area.

Food Truck Vendors: all above information applies except there will be outdoor parking spaces made available for your trucks. A limited amount of trucks will be selected, 1-2 per day. Please send in the entire menu list you will be offering during this event. No electricity, water or generators are available. Generators must be quiet, free of fumes and disturbances. County permits required. Further permitting may be required.

### Vendor Attendance

Smoking and pets are prohibited by vendors in the market area.

NO changing, sharing, switching, selling, sub-letting booths.

Windy Acres Farm has the right to screen all merchandise and dismiss any crafters who do not display their materials appropriately.

Clean up: Vendors are responsible for cleaning up their selling space before leaving including all trash accrued. Please do not leave any items to be disposed or a fine may be incurred.

There is no dumping allowed.

#### Hold Harmless and Indemnification

Vendor agrees that neither Windy Acres Farm, Inc. nor The Wayne Srail Living Trust shall be liable for injury to the vendor's business or any loss of income therefrom, or for personal injury or damage to the property of the Vendor, its employees, invitees, customers or any other person in or around the Vendor's section, regardless of whether the injury or damage results from conditions arising from other sources or places (including, but not limited to, weather conditions, power outages, or other similar occurrences) and regardless of whether the cause or means of repairing the conditions is inaccessible to the vendor. Vendor further agrees that Windy Acres Farm Produce, Inc. shall not be liable for any damages arising directly or indirectly from any act or omission of event sponsors or any customer at the event.

To the fullest extent permitted by law, the Vendor shall indemnify, keep safe and harmless Windy Acres Farm Produce, Inc., The Wayne Srail Living Trust, and their agents, officers, employees and any other public or private property owner whose property is used for this event, against all injuries, death, losses, damages, claims, suits, liabilities, judgements, costs, expenses, which may arise directly or indirectly from any negligence or reckless or willful misconduct of the vendor, its employees or agents. The Vendor shall, at its own expense, appear, defend, and pay all charges of attorney's and all costs and other expenses arising therefrom or incurred in connection therewith. If any judgement shall be rendered against Windy Acres Farm Produce, Inc., The Wayne Srail Living Trust or any other property owner in any such action, the Vendor shall at its own expense, satisfy the discharge of the same.

#### Certificate of Insurance, if applicable

All vendors must provide binding proof of comprehensive public liability insurance. The policy must include coverage against personal injury or death, property damage, occasioned by reason of the operations conducted by vendor, and products liability. Your policy must include minimum policy limits of one millions dollars (\$1,000,000) for bodily injury or death, and products liability to one or more persons in any one accident or event, and fifty thousand dollars (\$50,000) for damage to property resulting from any one accident or event. Windy Acres Farm Produce, Inc. reserves the right to increase minimum policy limits.

Upon acceptance into the market, the vendor must name Windy Acres Farm Produce, Inc. as additional insured, and provide Windy Acres Farm with an insurance certificate as proof of such coverage. Windy Acres Farm reserves the right to demand more additional insured's as necessary.

Proof of Vehicle Insurance for any vendor vehicle is required.
